



PRIVACY PROTECTION NOTICE – Bosch Hockenheim Historic

We are delighted about your interest in the Bosch Hockenheim Historic & would like you to feel comfortable and secure, and therefore take the confidentiality and integrity of your personal data very seriously.

Group C/GTP Racing Ltd processes your personally identifiable data (Personal Data) according to the principles of the European General Data Protection Regulation (GDPR).

Group C/GTP Racing Ltd is the controller of data collection and data processing.

Therefore, we will carefully process and use your information, and in accordance with legal data protection requirements, and will not disclose your information to any third party without your consent.

We will collect, process, and use the Personal Data provided by you exclusively for the stated purposes, unless you give us your consent for further uses.

In compliance with the principle of data economy, we undertake to minimise the collection, processing, and use of Personal Data to the extent possible. For example, we will collect Personal Data in conjunction with entries submitted for participation in the Bosch Hockenheim Historic

What type of Personal Data will be collected?

Information pertaining to names, addresses, communication, dates of birth, vehicle data, and bank details.

Purposes of data processing

We will use your information in accordance with our objective of providing you with the best possible racing and service experience, including comprehensive information.

In doing so, we will handle your information in a responsible manner and exclusively for the stated purposes.

In detail, we will use your information for the following purposes:

Activities relating to your participation in the Bosch Hockenheim Historic i.e. provision of the respective services, Mailing of our email Newsletter and/or press releases in the event that you signed up to receive this information, Market research and advertising/promotional activities on our own behalf, Our own analyses and statistical purposes (anonymised).

Data disclosure, data transmission

To deliver our offering relating to the Bosch Hockenheim Historic, we require partners to whom your Personal Data will be transmitted on a case by case basis. These partners, without exception, are involved in the delivery of services via agreements according to Art. 28 GDPR. Health-related data will exclusively be transmitted to parties entrusted with the provision of assistance (e.g. emergency response, ambulance services, air rescue) and to insurance companies.

Group C/GTP racing Ltd will not disclose your information to any third party for commercial purposes (sale, hire/rental) and is not engaged in any address trade. Your Personal Data will be stored in accordance with statutory retention periods.

Rights of data subjects acc. to Articles 13/14 GDPR

As a data subject you have the following rights in respect of the storage and processing of your Personal Data:

Right of revocation

You may revoke your consent, if previously provided, at any time and without stating reasons, and object to processing.

Right to information

You have the right to request from us at any time information about your Personal Data stored and processed by us. In the event that your information is not or no longer correct or complete you may request at any time that we rectify and/or complete your information.

Right to erasure

You have the right to erasure of your Personal Data processed by us. Should you request the erasure of your Personal Data from us, we will carefully review your request and, unless prohibited to do so by statutory retention periods, erase your Personal Data.

Right to restriction of processing

Should statutory retention periods oppose your request for erasure, we will restrict your Personal Data for processing.

Right to portability

You have the right to receive your Personal Data from us at any time in a structured, commonly used, machine-readable and interoperable format that allows you to transfer the data to another controller.

Right to lodge a complaint

Should you have reason to complain about our data processing, you have the right to lodge a complaint with our data protection officer, zoe@groupcracing.com
