- i. In consideration of Group C/GTP Racing Ltd ("Group C") acceptance for participation in Group C Events this year, the undersigned owner, competitor, driver and/or co-driver of race car(s) accepted for such Event(s) ("Participants"), on behalf of himself/herself and his/her respective next of kin, personal representatives, successors and assigns, hereby:
- ii. RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, Participants, racing associations, sanctioning organizations, Group C/GTP Racing Ltd ("Group C") track operators, track owners, track officials, track employees, car owners, drivers, mechanics, pit crews, corner workers, stewards, race officials, and any persons in any RESTRICTED AREA during the Events, rescue personnel, advertisers, sponsors, owners and lessees of the Event venue, and Event inspectors, scrutineers, surveyors, underwriters, consultants and others who offer recommendations, directions and instructions or engage in risk evaluation or loss control activities regarding the premises, race cars, Participants or otherwise relating to the Event, and each of them, and each of their respective officers, directors, agents, legal representatives, employees, contractors, members, consultants, affiliates, successors and assigns (collectively referenced herein as "Releasees") FROM ALL LIABILITY TO THE UNDERSIGNED, and his/her personal representatives, successors, assigns, heirs and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIMS OR DEMANDS THEREFOR, ON ACCOUNT OF INJURY TO PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED, ARISING FROM OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
